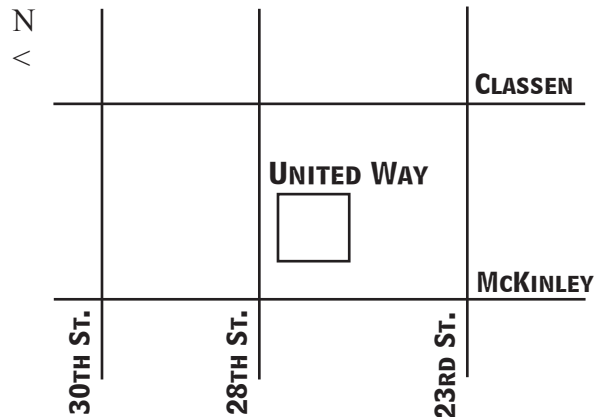

WHO QUALIFIES:

- Families with 3 or more children who earn **\$43,352, or \$48,363** if Married Filing Joint
- Families with 2 or more children who earn **\$40,363, or \$45,373** Married Filing Joint
- Families with 1 or more children who earn **\$35,535, or \$40,545** Married Filing Joint
- Families without children who earn **\$13,460, or \$18,470** Married Filing Joint

TO BE ELIGIBLE FOR FILING, PLEASE BRING:

- Photo identification
- Social Security cards for each family member on the return
- W-2s for all jobs worked in 2010
- 1099s for other sources of income, if any
- 2009 tax return (if possible)
- Day care expenses with childcare provider name, address, and tax I.D. number

NOTE: If married filing jointly, both spouses need to be present to sign the return

TO RECEIVE A FAST TAX REFUND ELECTRONICALLY, ALSO BRING:

- A voided check
- Your bank routing number
- Your bank account information
